

**Miniatures in Mariposa
Sierra Artists Gallery
March 9-21, 2010**

Eligibility- This is an open juried exhibition, and all artists are invited to participate. Work must be original by the artist.

Size- Image up to 8" by 10" (not including frame). Sculptures not exceed 6" x 6" x 6" including base.

Media- Acceptable media are:

Drawing (pencil, charcoal, ink, pastel, colored pencil, and clayboard) Paintings (watercolor, acrylic, and oil)

Mixed media

Sculpture / Three dimensional

Framing- All work must be presentation ready using hanging wire. **(No saw tooth hangers please)**

All watercolors and drawings must be under glass or plexiglass.

Labeling- All works must have the following information firmly affixed to the back of piece, or bottom of sculpture. Please include title, medium, price, artist's full name, phone # and e-mail (if applicable). See forms below.

E-mails will only be used for contact purposes for artwork entered or future shows.

Categories- Awards will be given in the following categories: Still life, animal, portrait, landscape, seascape, 3 dimensional.

Entry Fees- \$25 for up to six submissions, \$20 for up to three submissions, and \$10 for a single submission. All work must be for sale. Sierra Artists Gallery will take a 30% commission on all sales. Entry fees are non-refundable and must accompany the entry form.

Delivery and pick up- All entries must be hand delivered to Sierra Artists Gallery no later than Friday, March 5. Pick up of entries, accepted or not, will be after 3:00 pm. Sunday, March 21. An artists reception will be held on Sunday, March 21, 1:00 to 3:00 pm.
